

Purpose of Airport Roles

- Classify functions and activities at airports
- Coordinate planning of facilities
- Identify facility needs based on activities supported


To understand how airports contribute to the community and state



Identifying Airport Roles

- Reviewed latest NPIAS (2021-2025) update
- Evaluated multiple airport classification methodologies
- Adhere to NPIAS classifications with exceptions:
 - Any airport supporting scheduled air service was classified as "Commercial Service"
 - Non-NPIAS and NPIAS Unclassified became "Illinois Unclassified"
 - NPIAS Local airports with 100+ Jet Operations became "Illinois Regional"




Existing System Adequacy


- Why do we do it?
 - Understand how the system is currently meeting IASP goals
 - Helps to identify areas for project recommendations in future tasks
- What do we use to evaluate system adequacy?
 - Performance Measures (PMs) Actionable Items
 - Performance Indicators (Pls) Information Only
 - Facility and Service Objectives (FSOs) Recommended minimum levels of development for each IASP role
- How do we analyze PMs, PIs, and FSOs?
 - Use data collected during the Inventory phase to determine performance at the airport level, by classification, and statewide



Existing System Adequacy Example

- Goal 1: Economy
 - Performance Measure: Percent of airports that have completed master plan/ALP in the last 10 years (2010 or newer)







Presenting System Adequacy Results

- Each PM and PI will be analyzed and presented within the System Adequacy chapter of the IASP
- Results will be organized by Goal and PM or PI
- Inventory of System Conditions chapter will be combined with the System Adequacy Chapter
- Gaps or deficiencies result in (project/policy) recommendations!


- Economic Impact Data Collection and Surveying Continues!
